Sisler <u>Hall!</u>

The Chemistry Research Building has been renamed Harry H. Sisler Hall. The October 22, 2008 renaming ceremony included remarks from Dr. Steven Scott from the Board of Trustees, Dr. Joseph Glover, Provost of the University, CLAS Dean Dr. Paul D'Anieri and Dr. Daniel Talham, Chair of Chemistry. Members of Harry's family unveiled the new Sisler Hall sign. Many of you will remember Prof. Sisler from his long tenure in our department. He came to Florida in 1956 from Ohio State University and took a strong leadership role in building our department into a first-rank unit. Harry also served as Dean of the College, Executive Vice President, Dean of the Graduate School and Director of Sponsored Programs. He was a dedicated teacher, an admirable administrator, and is widely remembered as father of the modern UF Department of Chemistry.

We are very proud to recognize one of our own for his academic contributions to the Department of Chemistry, the College of Liberal Arts and Sciences, and the University of Florida by renaming CRB to Harry H. Sisler Hall. This recognition is due to the efforts of many people.

I recall first hearing the suggestion to rename CRB in 1991 at a faculty meeting. I have a vivid memory of thenchair Mike Zerner declaring, "We should name CRB after Harry Sisler". I was only mildly disillusioned when it didn't happen the way Mike said it should. In preparation for this event, I had a chance to look back at some old files that revealed the effort that started back in 1991.

A letter from Mike Zerner to Harry Sisler:

Dear Harry,

Could I please have a one page narrative style resume of the life and times of Harry Sisler. This should be double spaced so that I can ad-lib. So what is it for? None of your business! Sincerely,

In a letter dated October 1992, from Mike to then Provost Andrew Sorensen outlining the case, Harry's biosketch was included. Shortly afterwards, a memo from Provost Sorensen responding to Mike outlined details of the uphill battle such a proposal would face, and thanked Mike for his enthusiasm.

The paper trail stops there, but I can still see Mike coming to the faculty to announce that the administration wouldn't go for the renaming. "They are only naming buildings after big donors," he stated.

Mike was not to be deterred, "But we are going to do it anyway. We are just going to start calling it Sisler Hall.

New ACS Journal

Let them try and stop us," he declared. From then on, all departmental correspondence referred to Sisler Hall. I think Mike even went so far as to put up some signs.

My faith was restored, but of course it didn't stick. Nevertheless, the idea was planted, waiting for its time.

That time is now here. Our colleague, Dean Emeritus Will Harrison, got us started again, by drafting a resolution last year that was approved by the faculty and signed by EVERY faculty member in the department. Rick Yost, then-President of the Faculty Senate, guided the resolution through the Honorary Degrees, Distinguished Alumnus Awards and Memorials Committee. Finally, President Machen and the Board of Trustees bucked

the trend of naming only after big donors and made a very loud statement about the high regard the University of Florida holds for achievements in scholarship and education.

We honor Harry Sisler for leading the way during the late 1950's, 1960's and even into the 1970's, transforming Chemistry into a modern, nationally recognized Department. Harry was always quick to point out, "I didn't do anything by myself." He would want to include all of his colleagues in this recognition. So along with Harry, this renaming pays tribute to that era in our Department's history, and all of the students, staff, and faculty who contributed during this remarkable period.
