Course Objectives: At the end of the semester, students will be able to recognize common organic functional groups and name organic molecules using IUPAC nomenclature rules, correlate molecular structure and properties, draw basic reaction mechanisms and use them to account for/predict the products or starting materials of reactions (addition, substitution, and elimination reactions of alkenes, alkynes, alkyl halides, alcohols, ethers and epoxides), and propose multistep syntheses for organic molecules.
